Central Ohio Significant Storm Information for Month:  
June 2-6: Relatively brief periods of showers and thunderstorms, some with very heavy rain, over this 5-day period. Heaviest rains generally fell during the early to mid-evening hours on June 2, and during the morning hours of June 5. The majority of our volunteers reported between 1.5 and 3.0 inches of rain during the 5-day period, with amounts of 4.0 to 4.5 inches in a band extending from Powell to Sunbury in Delaware County. During the evening storms of June 2, several flood warning gages recorded amounts of 0.7 to 1.0 inch of rainfall in 15 minutes, and several CORN volunteers reported amounts of 1.0 to 1.1 inch of rain in 20 minutes. An EF0 tornado occurred during the early morning hours of June 6 near Marysville in Union County. Five fatalities were reported in association with a tornado that struck northern Ohio during the late evening of June 5; Millbury in Lake Township, Wood County was especially hard-hit.
